The Client shall use the vehicle with care, pay all fines and expenses related to moving or parking violations. The Client is not authorized to have repairs done to the vehicle except for those related to a flat tire, empty fuel tank, or dead battery, for which the Client must pay.</p>

Article 1 :

Rates

The rental fee is payable in advance.

The daily rate is calculated on a 24-hour basis. If the vehicle is returned later than the appointed hour, another day will be added to the total amount due.

The Client shall assume all fuel and oil costs. If the vehicle is returned without the requisite amount of fuel as noted on the contract, the Client shall be charged 20 Euros over and above the amount due for the rental of the vehicle.

The Client shall assume the payment of all fines and expenses associated with any driving infractions, whether moving or parking violations.

Article 2 :

Security Deposit

The deposit, as specified in the contract, shall be forfeited in part or in whole by the Client, should the vehicle be damaged or stolen, or should the vehicle not be returned in the same condition as it was when it was delivered to the Client.

If the amount due exceeds the amount of the deposit, the Client agrees to immediately pay the entire balance. If the amount due is less than the amount of the deposit, Fenouilledes Motos pledges to immediately refund the difference.

Article 3 :

Insurance

The vehicle is covered by Third party collision damage only. It is the clients' responsibility to ensure adequate personal health insurance is taken out before the commencement of the rental period.

In the case of theft or damage to any accessories, which are not insured, the Client agrees to assume the costs of their replacement or repair.

In the case of accident or theft, the Client's liability is equal to the amount of the deposit.

In the case of the vehicle's theft, accident, or damage by fire, the Client agrees to immediately inform Fenouilledes Motos.

If the vehicle is involved in an accident, the Client must inform Fenouilledes Motos in writing within 48 hours of the accident. The Client shall send by registered mail a copy of the jointly-filed accident report as well as a written declaration describing the circumstances of the accident and the identity of the parties involved in the accident.

The Client must possess a European motorcycle licence sufficient enough to ride up to a 125cc motorcycle or be in possession of a European car driver's licence for more than two years. The drivers' license must have neither been suspended nor revoked.

Article 4 :

Terms and Conditions

Fenouilledes Motos pledges to rent the aforementioned vehicle to the Client whose signature appears on the contract.

The rental is personal and non-transferable. It is valid for a specific period as specified by the contract.

The Client agrees that the vehicle and its accessories are in good working condition and in compliance with all legal requirements.

By signing the contract, the Client accepts the condition of the vehicle as described in the contract and agrees to return the vehicle in the same condition, both in terms of its working condition and its overall appearance.

Any reservations regarding the vehicle's appearance must be noted in the space provided for such comments on the contract¹ by the Client.

The Client must submit a valid European drivers licence (*see article 3*) and proof of ID (*passport, personal identification*) before the commencement of the rental period.

When the Client takes possession of the vehicle, Fenouilledes Motos will provide the Client with a photocopy of the vehicle's registration and the insurance certificate.

The Client will assume full responsibility for failure to present these documents to authorities if asked.

Article 5 :

Restrictions

The vehicle shall be driven exclusively by the Client.

The vehicle shall not be driven outside metropolitan France without prior permission.

The vehicle shall not be used for public transport.

The vehicle shall not be driven on a designated race track or driven off-road without the prior written permission of Fenouilledes Motos.

Minimum age for motorcycle hire is 21 years of age.

Article 6 :

Maintenance

For rental periods in excess of one week (or over 2,000 kilometers), the Client shall conduct basic maintenance checks every 2,000 kilometers (i.e. oil level, tire pressure, etc).

The vehicle shall be brought to Fenouilledes Motos, for any adjustments or repairs, and any regularly scheduled servicing of the vehicle. Failure to comply shall engage the responsibility of the Client for any expenses required to repair the vehicle or bring the vehicle into compliance with legal regulations.

Article 7 :

Excursions

Fenouilledes Motos reserve the right to change or cancel the itinerary in the event of adverse weather conditions. Should the decision be made to cancel the day's itinerary it will be due to safety reasons. The final decision is to be made by Fenouilledes Motos and the appropriate refund of money will be made. Our partners at Globetrotters.org will ensure that alternative activities are made available should this be the case.

The routes planned demand a degree of rider awareness of conditions that he or she may not be familiar with. For this reason it is suggested that the Client has some experience of riding a motorcycle (minimum 2 years).
